THE DENTON COUNTY BAIL BOND BOARD SHALL MEET IN REGULAR SESSION TO CONSIDER AND POSSIBLY TAKE ACTION ON THE FOLLOWING MATTERS:

Effective March 16, 2020, Texas Governor Abbott suspended certain Open Meeting rules to allow telephonic or videoconference meetings of government bodies that are accessible to the public to decrease large groups of people from assembling. The suspension temporarily removes the requirement that government officials and members of the public be physically present at a meeting location. Denton County Commissioners Court meetings will temporarily be held via videoconference and will not be held at the Courthouse-On-The-Square.
