2019 – 2020 Influenza Surveillance Program

CDC Week 6, Week Ending February 8, 2020



Epidemiologic Overview

Denton County

- High influenza activity was reported in Denton County for week 6.
- 166 positive influenza tests (147 Flu A and 19 Flu B) and 17 hospitalizations were reported by Denton County sentinel providers for week 6.
- Syndromic surveillance for influenza-like illness (ILI) in Denton County decreased for week 6 when compared to the previous week.
- 1.0% of the total reported school population was absent due to ILI in week 6.
- 1 influenza-associated adult death has been reported in Denton County for the 2019-2020 season.

Texas

- Influenza activity in the state of Texas was reported as high for week 6.
- The percentage of visits for ILI as reported by ILINet providers increased to 11.6% in week 6 compared to the previous week.
- The percentage of specimens testing positive for influenza in Texas decreased to 28.5% in week 6 compared to the previous week.

US

- The proportion of outpatient visits for influenza-like illness (ILI) was 6.8%, which is above the national baseline of 2.4%.
- The geographic spread of influenza in 48 states was reported as widespread; and 2 states was reported as regional.
- The percentage of specimens testing positive for influenza in the US was 30.8%.
- The proportion of deaths attributed to pneumonia and influenza (P&I) from the National Center for Health Statistics Mortality Surveillance System for week 5 was 6.8%. This percentage is below the epidemic threshold of 7.3% for week 5.

Figure 2. Influenza Positive Tests and Percent Positive, Denton County Hospitals and Providers, 2019-2020 Season

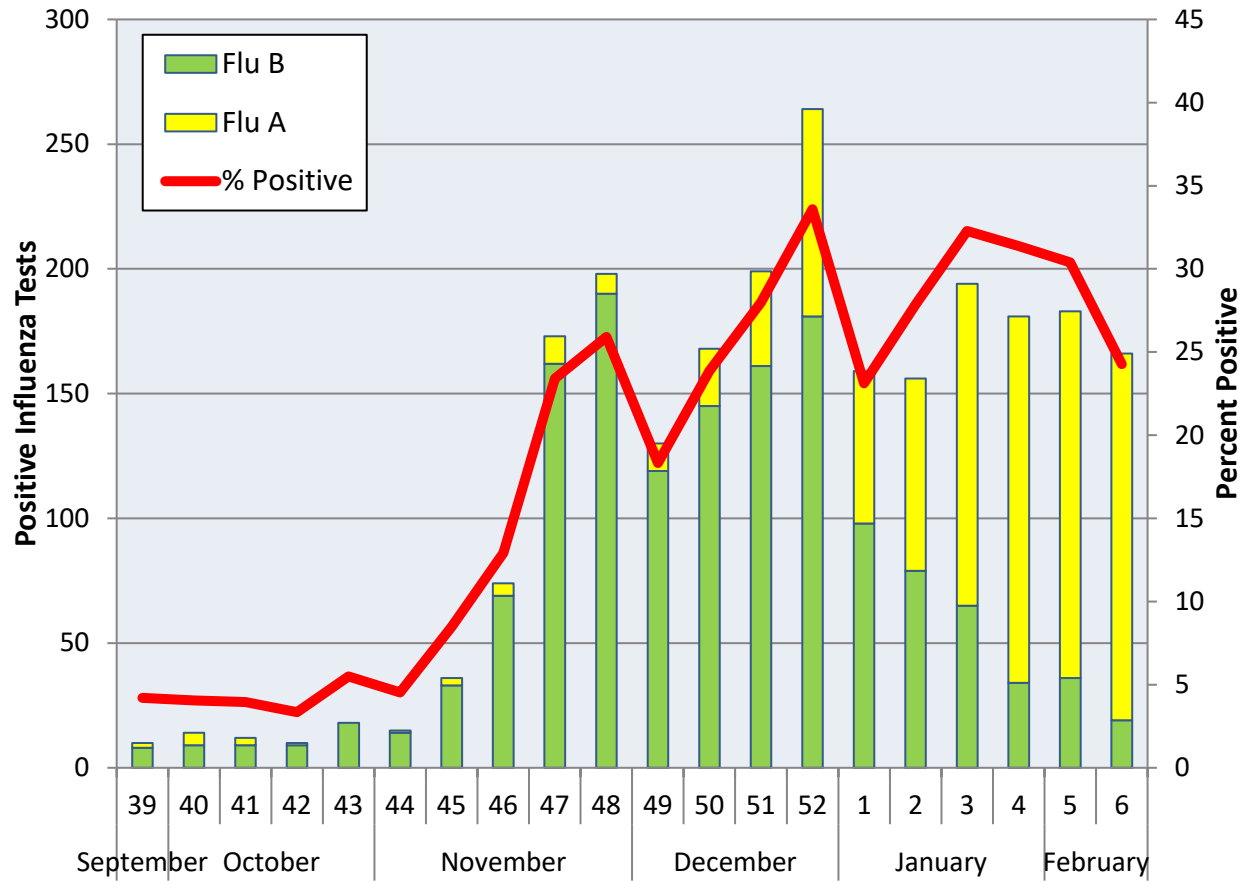
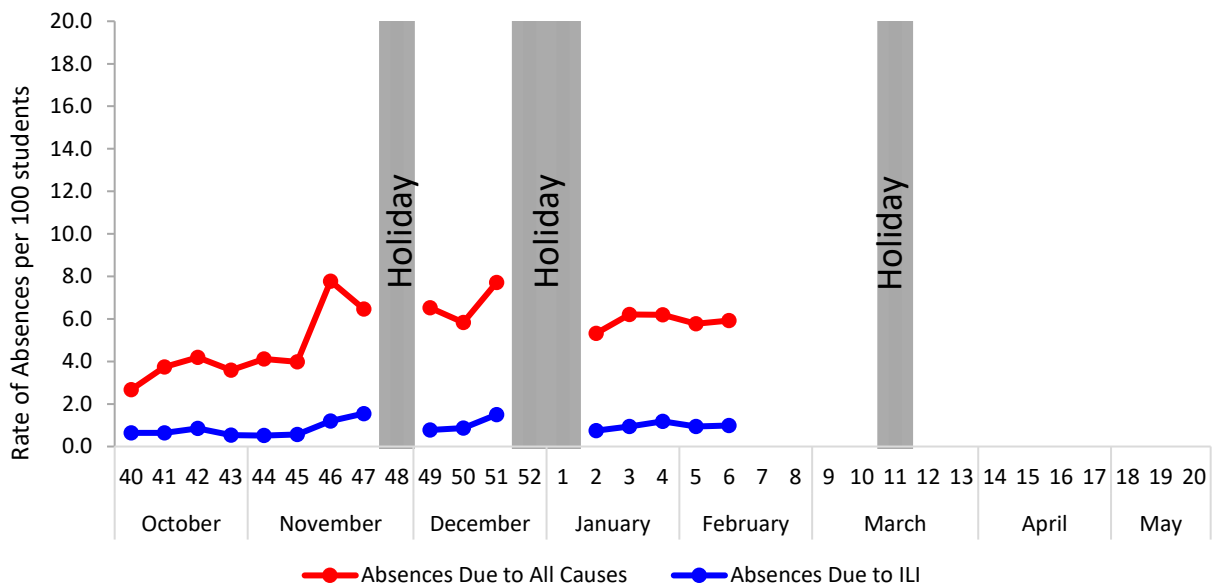


Figure 3. Percent of Absenteeism Due to All Causes and ILI, Denton County Schools*, 2019- 2020 Season

Figure 4. Influenza Positive Tests Reported to CDC by U.S. Public Health Laboratories, National Summary, September 29, 2019 – February 8, 2020

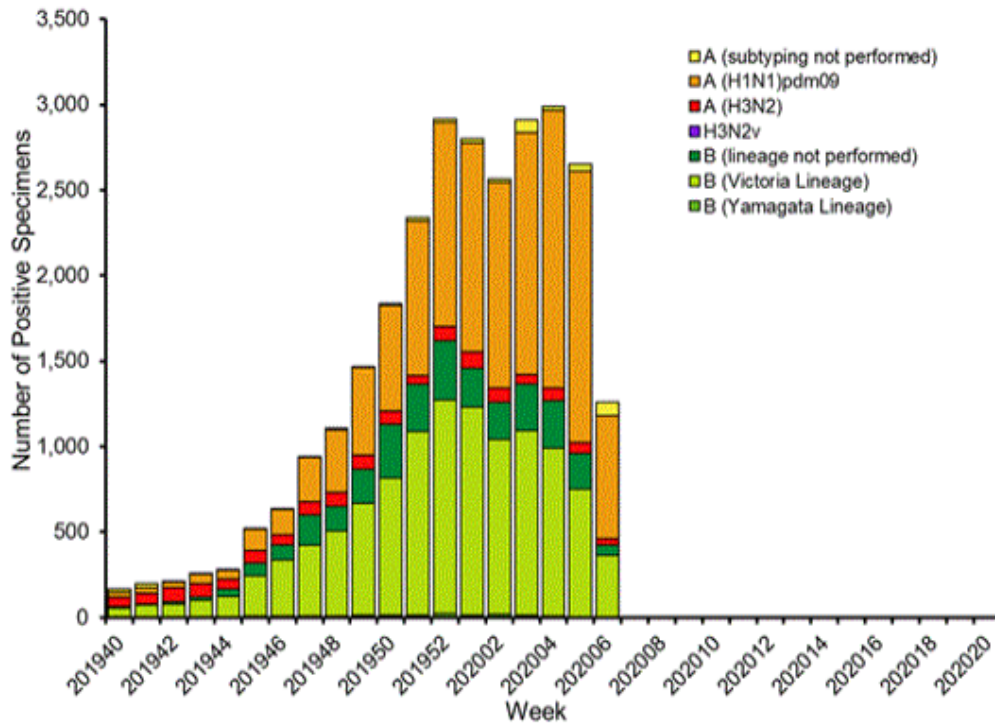


Figure 5. Influenza Positive Tests Reported to CDC by U.S. Clinical Laboratories, National Summary, September 29, 2019 – February 8, 2020

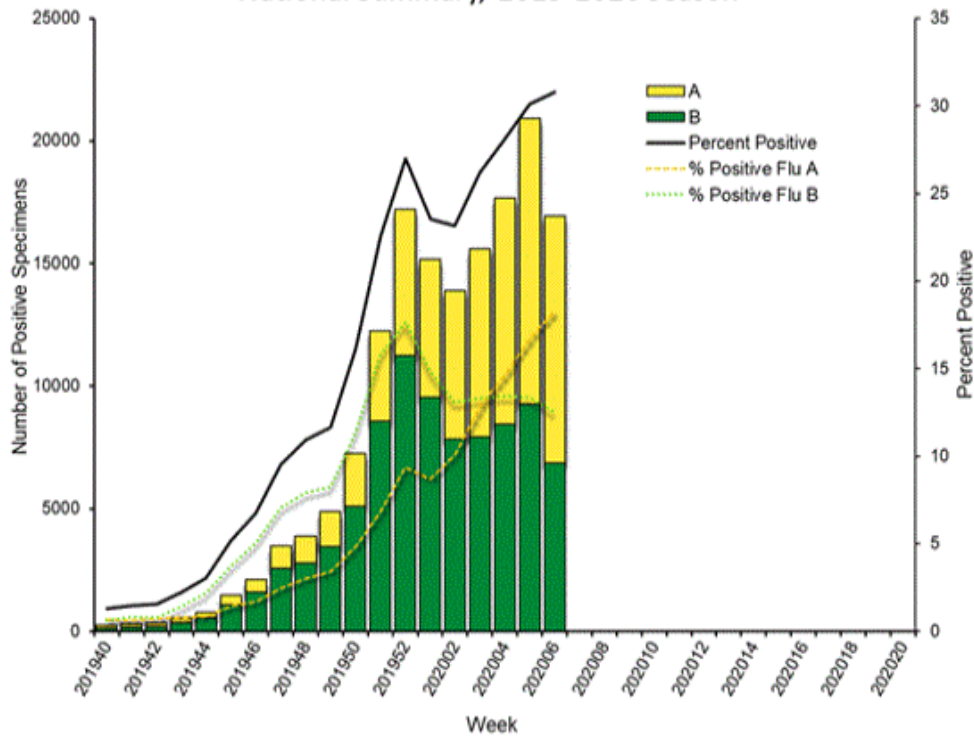


Figure 6. Antigenic Characterization of Influenza Isolates, Since September 29, 2019

Figure 8. ESSENCE Syndromic Surveillance for Influenza-like Illness: Denton County, August 1, 2019- February 8, 2020

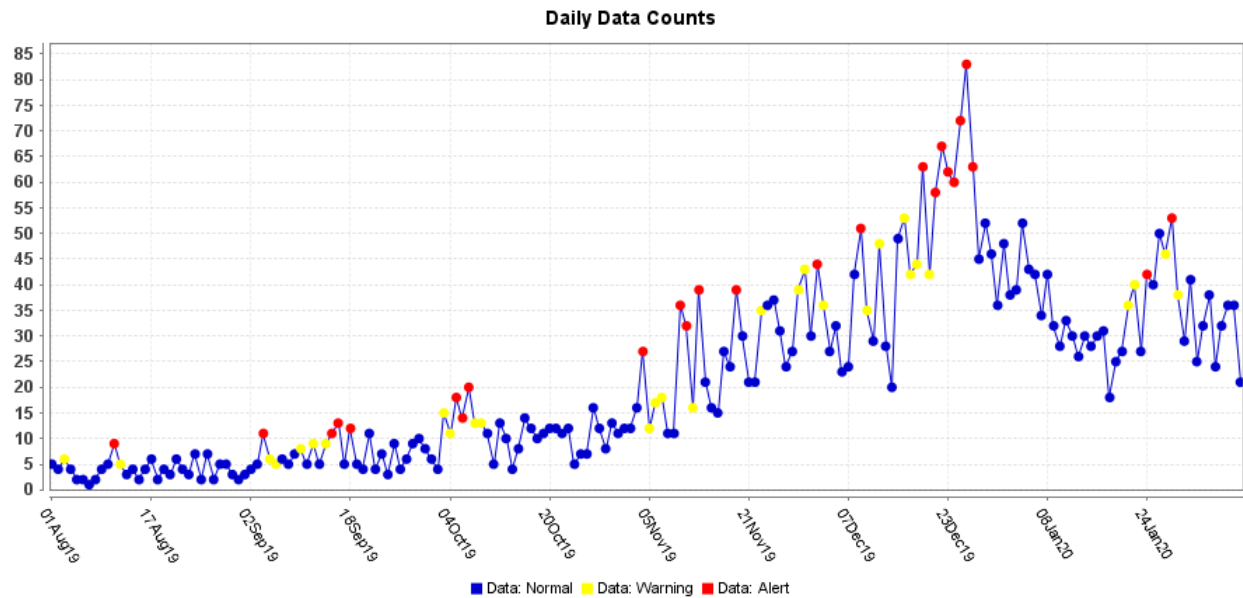
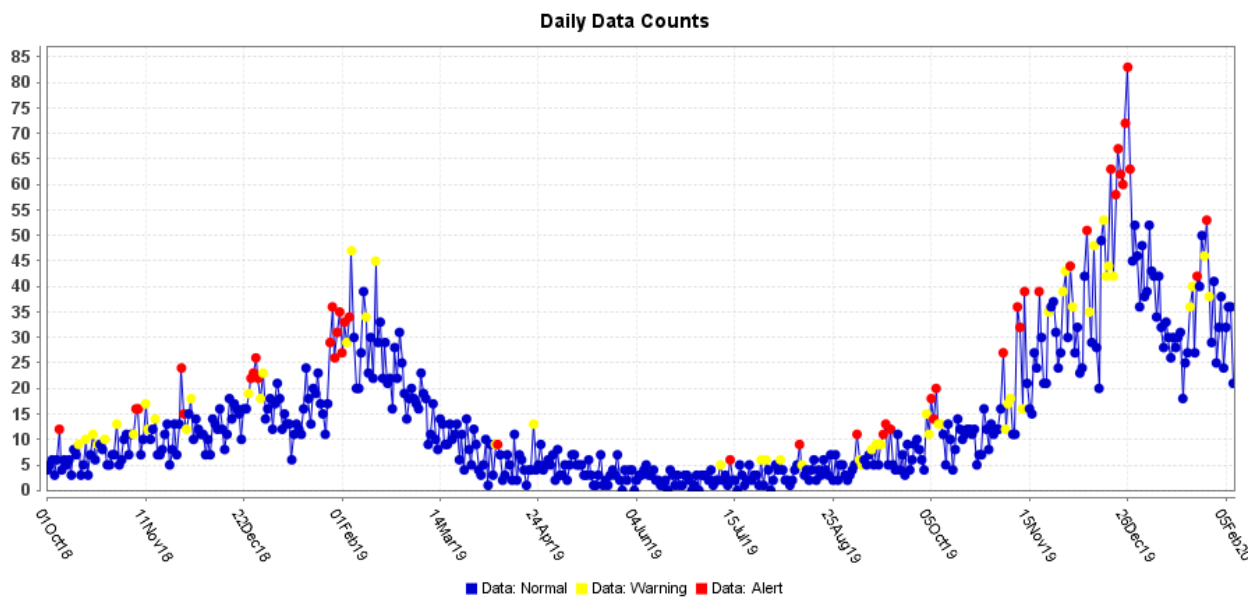


Figure 9. ESSENCE Syndromic Surveillance for Influenza-like Illness: Denton County, October 1, 2018 – February 8, 2020

Figure 10. Pneumonia and Influenza Mortality from the National Center for Health Statistics Mortality Surveillance System: Week ending February 1, 2020

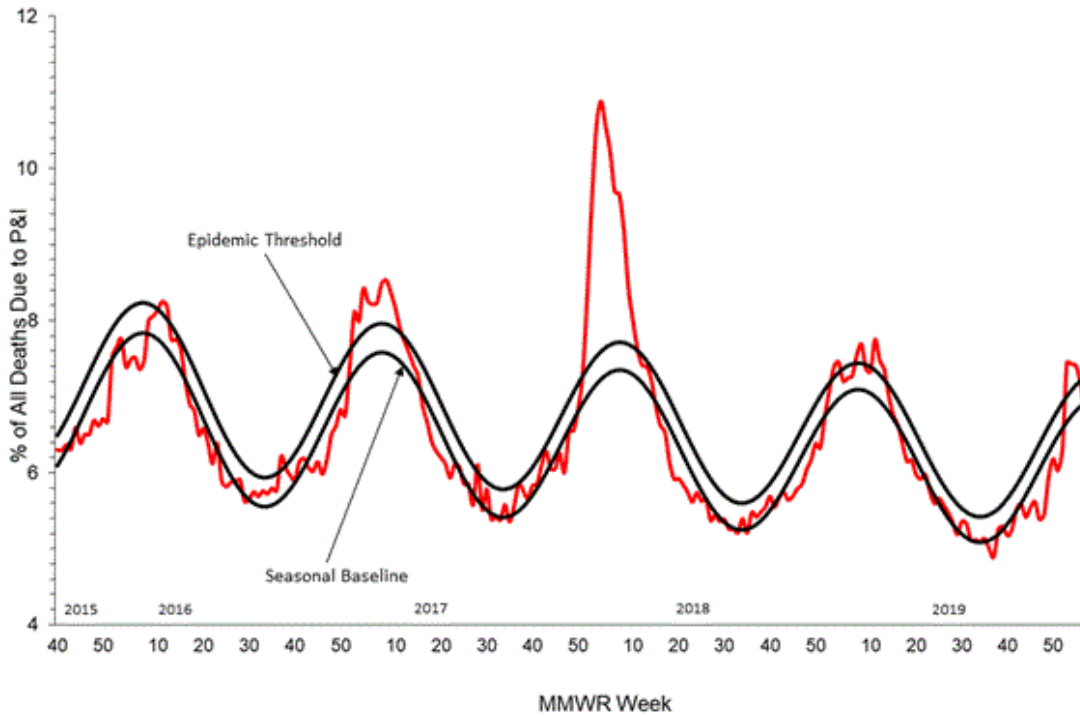
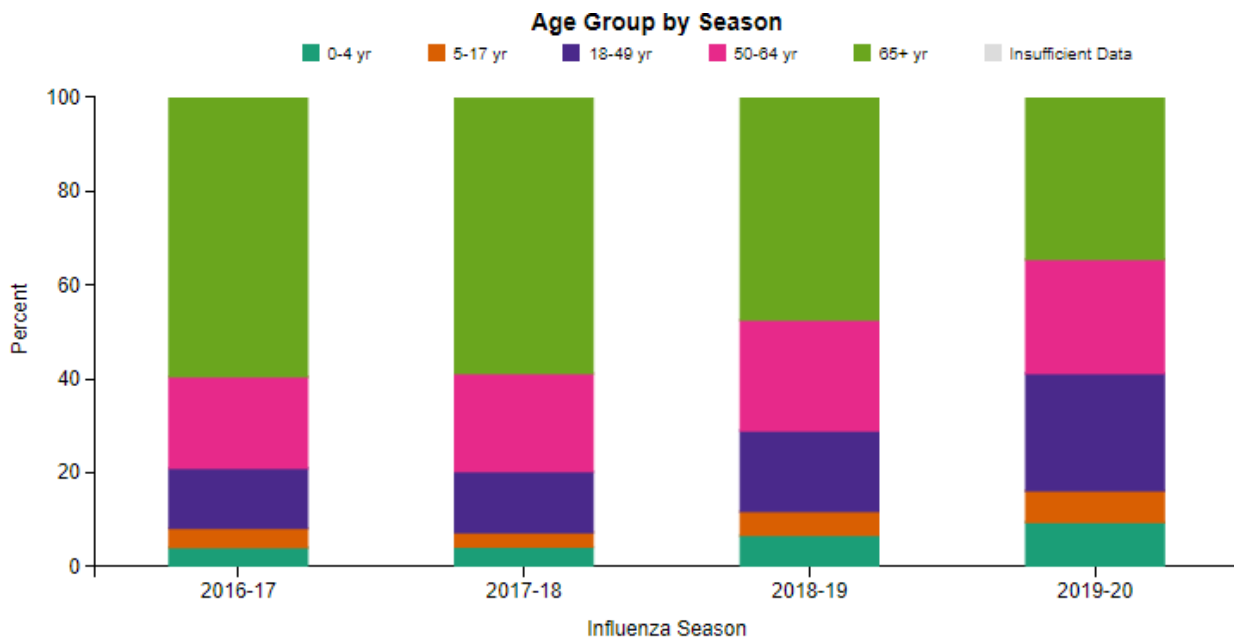
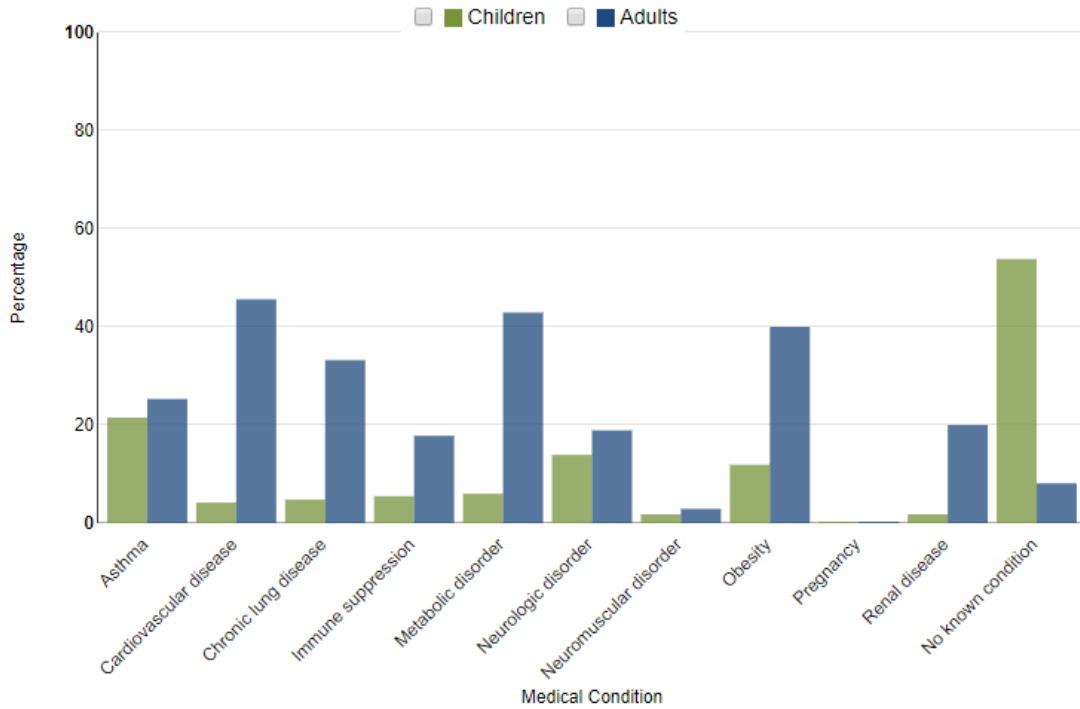


Figure 11. FluSurv-NET Laboratory Confirmed Influenza-Associated Hospitalizations by Age Group, National Summary, data as of February 8, 2020

Figure 13. Weekly Influenza Activity Estimates Reported by State and Territorial Epidemiologists: Week 6 – Week Ending February 8, 2020

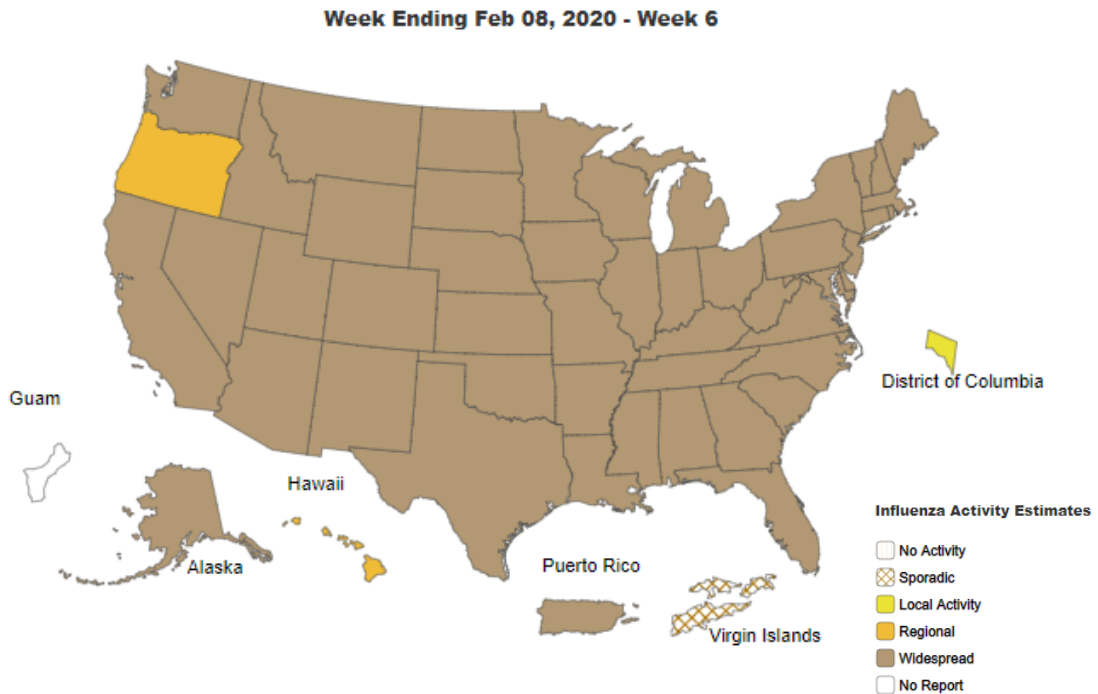
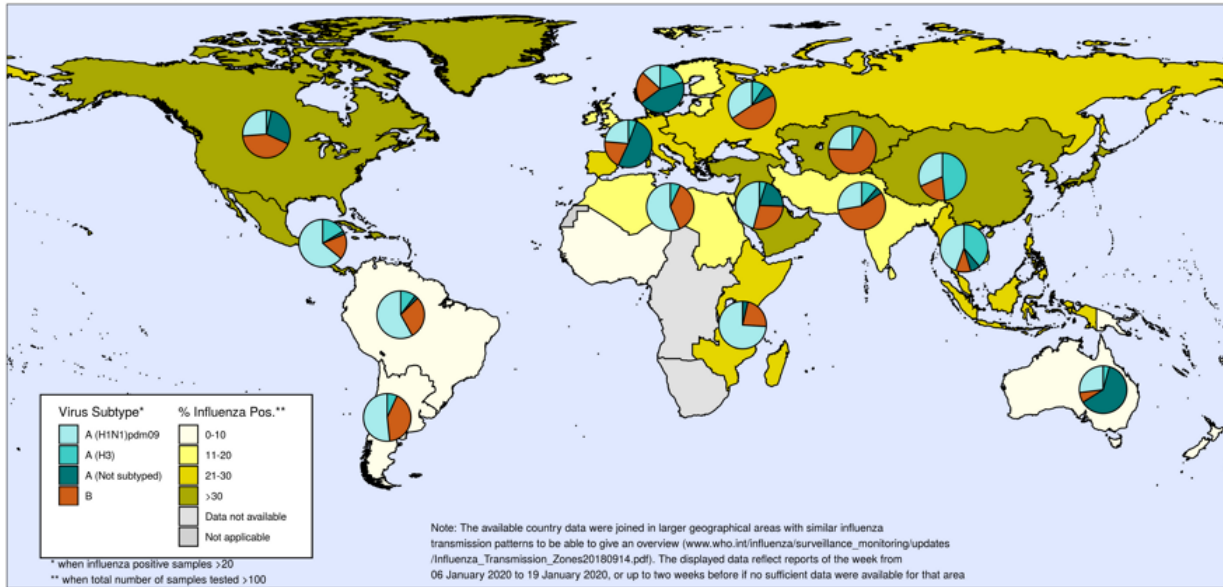


Figure 14. Percentage of Respiratory Specimens that tested Positive for Influenza: WHO, based on data through February 4, 2020
