**ORDER TO SERVE SENTENCE DURING OFF-WORK HOURS OR ON WEEKENDS**

**IT IS THEREFORE ORDERED** that the above-named Defendant is committed to the custody of the Sheriff of Denton County, Texas, but that Defendant is permitted to serve the sentence imposed during the Defendant's off-work hours or on weekends provided that the sentence is served exactly as follows:

1. Defendant is **ORDERED** to report to the Denton County Jail and shall be released on the following dates and times until the sentence imposed is served completely:

3. Defendant is **ORDERED** to abide by all current orders of this Court, the laws of this state and of the United States, and shall not consume alcoholic beverages within 12 hours of reporting to the jail.
4. Defendant is **ORDERED** to comply with all rules and regulations of the Denton County Jail.
5. Defendant acknowledges that work release/weekend service is not a right but a privilege that may be REVOKED at any time for good cause or proof of non-compliance with any provision herein.
