**INSTRUCTIONS:**

1. You must pay all costs of court, PLUS the \$9.90 Administrative Fee at **the time of this Request.**
2. You must provide the Court with a written copy of your driving record (TYPE 3A) from DPS at **the time of this Request.** You may go to the State of Texas website and request your driving record online ([www.texas.gov](http://www.texas.gov)).
3. Contact a Driving Safety Course Agency. You may take the DSC from any authorized agency within the State of Texas. There will be an additional cost payable to the agency you choose.
4. To complete disposition of the above charge and docket number, you must complete and show original proof of completion of your DSC to this Court by providing the Court Copy of your completion certificate on or before the DUE DATE. **Only the Court Copy** can be accepted as proof of your course completion.
5. If you do not complete the DSC requirements listed above on or before the DUE DATE, you **MUST** pay an additional fine of \$200.00
6. If you do not complete the DSC requirements listed above OR pay your fine, the Court will require your appearance to show cause why the proof was not submitted timely. At that time the Court may enter a judgment of guilt. If you fail to appear at the hearing, the Court will enter a judgment of guilt and the offense will appear as a conviction on your driving record, PLUS an additional fine will be assessed and become due and payable.

**AFFIDAVIT:**

1. I have a valid TX Driver's License or permit, it is NOT a commercial license (copy attached); OR I am a member, or the spouse or dependent child of a member, of the United States Military Forces serving on active duty (copy of Military ID attached).

2. My driving record as maintained by the Dept. of Public Safety does not indicate that I have successfully completed a driving course within the 12 months preceding the date of the offense.
3. I am not currently taking a driving safety course for the disposal of another moving violation that is not yet reflected on my driving record.
4. I have proof of financial responsibility - liability insurance. (copy attached)
5. I was not going 25 mph or more over the posted speed limit, OR speeding at a speed of 95 mph or more.

**PLEA:**
