**INSTRUCTIONS:**

1. Pay by check or money order costs and fees (contact the court for the amount), made payable to Denton County, and send it to the Court along with this request.
2. You must not be convicted of NOR RECEIVE any violation during the Deferral Period. NOTE: The "Deferral Period" includes the entire time through the Completion Date and until such time that the probation is completed by your filing of the sworn affidavit of your compliance of all Requirements of deferral.
3. **To complete probation of the above docketed charge, YOU MUST EITHER IN PERSON OR BY DULY DELIVERED U.S. MAIL OR ELECTRONIC FILING RECEIVED ON OR WITHIN 10 CALENDAR DAYS FOLLOWING THE COMPLETION DATE and sign a sworn affidavit that you have not been convicted of NOR RECEIVED a moving violation for the Deferral Period.**
4. Attach a copy of (1) valid current Texas Driver's License, (2) proof of Liability Insurance.
5. Complete a Driver Safety Course if you were under the age of 25 on the date of the offense.

**WARNING: If you fail to appear either in person or by duly delivered U.S. mail or electronic filing received on or within 10 calendar days following the Completion Date, a conviction can result.**

**AFFIDAVIT:**

1. I have a valid TX Driver's License or permit, and it is NOT a commercial license (copy attached), OR am a member, or the spouse or dependent child of a member, of the United States Military Forces serving on active duty (copy of Military ID attached)
2. I am not currently under deferred in any other court at the present time.
3. I have not been on deferred in this court within the 12 months preceding the date of the offense.
4. I have proof of financial responsibility - liability insurance. (copy attached)
5. I was not going 25 mph or more over the posted speed limit. I was not going 95 mph or more.
