GENERAL OVERVIEW

Executive Summary

During the response to COVID-19, it was determined there was a need for extended Broadband Services nationwide. Denton County plans to use state and local fiscal recovery funds under the American Rescue Plan to implement a broadband project. On August 10, 2021, Denton County Commissioners Court approved specifications of a Request for Qualifications (RFQ) for a Broadband Backbone Needs Assessment Study. This needs assessment will provide Denton County with information to prepare a solicitation for the design, installation and operation of a Broadband Backbone that will provide a path for internet services throughout Denton County. Our goals of this project include the following:

- Have the capability to deliver services to every household in Denton County and the ability to expand and provide services throughout Denton County.*
- Have the capability to allow local service providers to purchase services for their service area*
- Create a system to deliver a minimum of 100Mbps upload and download*
- Provide options to operate a Cooperative/Non-Profit to distribute and manage the system*

In addition, Denton County plans to use state and local fiscal recovery funds for Food Programs and Health/Emergency Response. We have not discussed the details of these projects to date.

Uses of Funds

We intend to use state and local fiscal recovery funds to hire a firm to assist with the establishment of a countywide Broadband Backbone Service. The cost of this service is unknown at this time as we are just in the beginning stages of the project. These funds will support the community by providing every household in Denton County with broadband service, delivering minimum speeds of 100Mbps upload and 100 Mbps download.

Denton County also plans to use some of the funds for Food Programs and Health/Emergency Response. Specific details of these programs have not been determined.

In addition, Denton County received Emergency Rental Assistance funds under the American Rescue Plan. We plan to use these funds to continue to help citizens by paying their rent and/or utility/home energy bills. Currently, we are still using Emergency Rental Assistance funds under the Consolidated Appropriations Act. This program helps prevent eviction and homelessness for those individuals who have been affected by the COVID-19 pandemic. To date, the majority of these funds have supported households at 30 percent Area Median Income and below (76.7 percent) with 23.5 percent for households at 30-50 percent AMI and 5.8 percent for households at 51-80 percent AMI. Black households are participating four times above respective county population; Asian households are participating three times above respective county population. For Hispanic households, we are seeing slightly under the respective county population. As a result, we have initiated multi-lingual outreach through local non-profit organizations, posters in area locations and flyers in outgoing food supplies. This is

the first level of outreach which will be expanded as needed to ensure equitable distribution of available funds to all eligible households in Denton County.

Promoting equitable outcomes

Equity has always been a value of Denton County. Equitable outcomes will be determined at a later date as we are in the beginning stages of our projects and specific details have not been determined.

Community Engagement

Denton County welcomes feedback from constituents and community-based organizations regarding projects funded with state and local fiscal recovery funds.

Our Broadband Project will serve all households in Denton County, which will include people of color, people with low-income, and other underserved groups.

Labor Practices

We will provide more detail on labor practices as our projects progress.

Use of Evidence

We are not currently using funds for evidence-based interventions.
